




2nd Quarter 2018 One Source Certified Contractor Report


In the second quarter of 2018 the OSCC program screened **1764 employees** / subcontractors of contractors requesting site access to restricted sites. Of the **1764 employees** / subcontractors screened, 128 employees / subcontractors did not meet the minimum requirements and were denied site access. This represents **7%** of the total group screened.
